The schedule for the 37th Annual World Championship ICE Racing Series is shaping up to be pretty darn good and may get even better in coming weeks. Pro Racers please return your filled out and signed paperwork as soon as possible with your intentions. On your Entry Form write in the events you will be participating or simply write ALL if you plan to run the whole WC Series this winter. It would also be a good idea to call me with your intentions so we're on the same page. As we have in the past ICE will be offering free equipment transportation for WC Series Tour Riders who need it. Let me know soon as you can as this service will be offered on a first come first serve basis.

ICE is introducing a new Silver Rocket competition racing stud this season. The physical dimensions are the same as the previous stud but the new one has a distinctive impression placed on it during the manufacturing process. The new Silver Rocket will not be mandatory this season but it will be next season. This new stud is designed to keep the playing field level, help prevent possible cheating and counterfeiting by others.

ICE blue numbers are required on the front of all pro machines Bikes and Quads. Clearly visible numbers on the sides of machines and backs of your racing jersey/leathers is also very important for our scorers to do their job as good as possible. You are the top Professional Racers in ice racing and I know you will be wearing your most colorful gear and having your machines looking spectacular for the fans to enjoy.

We are trying some two night weekends in a couple of markets at the request of the arenas. With those cities the Saturday night race will have full purse. The other race(s) will have less purse but will be full WC Points. These added races are special promotions featuring families and arena supporters appreciation races/events. These added events are good for making expense money. ICE is trying these events and other promotional options we have in an attempt to grow our series during these very tough economic times.

I'm looking forward to working with you this season for another exciting world Championship ICE Racing Series. Thank you for your continued support.
