



# NITRO X-KARTS

In the interest of allowing as many participants as possible to compete in the world's longest running and most prestigious arena ice racing series I.C.E. proudly offers competition in the – XTREME ICE SPEEDWAYKARTS/X-KARTS Class.

We have attempted to design the rules as straight forward and practical as possible allowing all manufacturers an opportunity to showcase their products as well as the stage for local/regional/national racers to prove their talents in front of large numbers of spectators.

Amateur Classes such as this are born from the spirit of sportsmanship, having fun and learning racing skills. Unless posted on an Official Entry Form no prize money shall be paid amateurs. Should all the racers agree in advance, on their own free volition, amongst themselves they may collect and pay out a 100% payback purse. Sponsorship awards and cash may also be collected (**but not at events**) and paid out. Recommended payback (but not mandatory): 50% of fees collected and sponsorships paid in go to winner; 30% to 2<sup>nd</sup> place and 20% to the 3<sup>rd</sup> place finisher.

## **RULES: The ultimate responsibility for complying with I.C.E. Rules and Regulations lie with the Participant.**

1. WKA Speedway Kart chassis and body rules in effect.
2. Wheels must be 5" or 6" diameter, maximum width 10".
3. Tire make and tread design optional. For ice racing must use Silver Rockets Racing Studs available from I.C.E. No tire cutting. Only four tires/wheels per kart.
4. ENGINE: Open 4-stroke, single cylinder. One engine only.
5. FUEL: Methanol, nitro is allowed.
6. Recommended minimum weight 350lbs.
7. Must have legible minimum 8" tall numbers on right front and both sides.
8. Must have full speedway style body covering nose, front wheels and sides outside of nerf bars. Body can be either fiberglass or plastic material.

**SAFETY:** Approved helmets, eye protection, gloves, shoes, long sleeve jacket, long pants, neck brace are mandatory. Full racing suits are welcomed.

**AGE:** Minimum age is 18. Drivers age 16 and 17 with a minimum of 2 years previous racing experience may also be eligible to race with properly completed parental consent forms.
